On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington rose by 7,100 from March 2018 to April 2018. BLS estimates the private sector gained 6,500 jobs during the month and the public sector gained 600 jobs.

On a not seasonally adjusted basis, estimates for April 2017 through April 2018 indicate an increase in employment of 85,100 for the state. The private sector added 80,200 jobs while the public sector gained an estimated 4,900 jobs over the year.

Whatcom County

Local Area Unemployment Statistics

The unemployment rate in Whatcom County was 4.8 percent in April 2018 (preliminary), down from 5.2 percent reported in March (revised). The unemployment rate in April 2017 was 4.7 percent.

- Compared to April 2017, the number of people counted as 'employed' increased by 612 and the number of people counted as 'unemployed' or actively seeking work increased by 138, resulting in a 0.7 percent increase in the size of the labor force. Whatcom County's labor force was about 109,766 in April.
- Initial claims for unemployment benefits in Whatcom County decreased from 598 in March to 549. Altogether, 1,394 Whatcom County residents collected unemployment insurance benefits in April; down from 1,554 in March.

Total nonfarm payroll in Whatcom County increased by 100 from March to April 2018. Year-over-year, the tally of nonfarm jobs was up 1,800 or 1.9 percent.

• In April, goods producing industries collectively added 300 jobs. Private services providers added 500 and government shed 700 jobs. The largest one-month gains were observed in construction (+300) and the deepest losses were attributable to government (-700).

• Over the year, all but two of the major industries covered by this report added jobs. The largest gains were observed in construction (+900) and leisure and hospitality (+600). Government and retail trade each shed jobs over the year (-700 and -100 respectively).

Skagit County

Local Area Unemployment Statistics

The unemployment rate in Skagit County was 5.4 percent in April 2018 (preliminary), down from 5.8 reported in March (revised). The unemployment rate in April 2017 was 5.4 percent.

- Compared to April 2017, the number of people counted as 'employed' decreased by 311 and the number of people counted as 'unemployed' increased by 9. Skagit County's labor force was estimated at 58,511, having decreased by 0.5 percent over the year.
- Initial claims for unemployment benefits in Skagit County increased from 405 in March to 418. Altogether, 994 Skagit County residents received unemployment insurance benefits in April. This is down from 1,051 in March.

In April 2018, Skagit County nonfarm payrolls increased by 700. Year-over-year, the tally of nonfarm jobs expanded by 700 or 1.4 percent.

• Over the month, most major industry sectors detailed in this report added jobs. The largest increases were attributable to hiring by construction (+300). No industries reported one month losses.

• Over the year, most industries added jobs, with the largest gains attributable to hiring by construction and manufacturing (200 each). Trade transportation warehousing and utilities shed 300 jobs, specifically from retail trade.

Island County

Local Area Unemployment Statistics

The unemployment rate in Island County was 5.6 percent (preliminary) in April 2018. This is down from 5.8 percent in March (revised). The unemployment rate 12 months ago was 4.9 percent.

- Compared to April 2017, the number of people counted as 'employed' increased by 51 and the number of people counted as 'unemployed' or actively seeking work expanded by 237, pushing the unemployment rate up over the year. Island County's civilian labor force was estimated as 34,001, an increase of 0.9 percent over the year.
- There were 150 initial claims for unemployment benefits in Island County in April down from 183 in March. Altogether, 437 Island County residents collected unemployment insurance benefits in April. This is down from 464 in March.

Nonfarm payroll jobs in Island County increased by 100 from March to April 2018 Year-over-year, the tally of nonfarm jobs was up 240 or 1.4 percent.

- From March to April, most major industries added jobs. The largest month-to-month increases were observed in leisure and hospitality and government (50 and 30 respectively).
- Year-over-year, most major industries detailed in this report added jobs. The largest gains were observed in education and health services (+200). The deepest losses were attributable to professional and business services (-200).

San Juan County

Local Area Unemployment Statistics

The unemployment rate in San Juan County decreased from 4.5 percent in March (revised) to 4.2 percent (preliminary) in April 2018. The unemployment rate in April 2017 was 3.9 percent.

- Compared to April 2017, the number of people counted as 'employed' decreased by 6 and the number counted as 'unemployed' or actively seeking work increased by 25, pushing the unemployment rate up over the year. Altogether, the San Juan County labor force consisted of an estimated 7,853 people and increased by 0.2 percent over the year.
- Initial claims for unemployment benefits in San Juan County decreased from 14 in March to
 9. Altogether, 62 San Juan County residents received unemployment insurance benefits in April. This is down from 78 in March.

Net nonfarm payroll in San Juan County increased by 150 from March to April 2018. Year-over-year, total nonfarm employment was up 40 jobs or 0.7 percent.

- San Juan County has a highly-seasonal economy, due to its orientation toward tourism. Most industries shed jobs in the winter and return with the sun. In April, most industries added jobs. The largest increase was attributable to the county's largest industry: leisure and hospitality (+60). Education and health services is the only industry that did not expand employment in April.
- Over the year, there was a net gain, with a mix of industry-specific gains and losses; the largest gains were observed in construction and manufacturing (+40 each). The deepest losses were observed in leisure and hospitality (-50) and government (-40).
