On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington rose by 6,100 from January 2017 to February 2017. BLS estimates the private sector gained 4,100 jobs during the month and the public sector gained 2,000 jobs.

On a not seasonally adjusted basis, estimates for February 2016 through February 2017 indicate an increase in employment of 85,100 for the state. The private sector added 73,100 jobs while the public sector gained an estimated 12,000 jobs over the year.

Washington's preliminary seasonally adjusted unemployment rate for February 2017 is 4.9 percent. The revised estimated January 2017 unemployment rate

Unemployment rate (not seasonally adjusted) was at 5.1 percent. The February 2016 unemployment rate was 5.6 percent.

BLS estimates of monthly job gains and losses are based on a survey of businesses. Preliminary estimates are subject to revision. January's preliminary estimated loss of 7,200 jobs was revised to a loss of 3,100 jobs.

# **Whatcom County**

### **Local Area Unemployment Statistics**

The unemployment rate in Whatcom County was 5.9 percent in February 2017 (preliminary), down from 6.3 percent in January (revised). For comparison, the unemployment rate in February 2016 was 6.7 percent. In the past year the downward-trending unemployment rate has slowed in its descent.

- Compared to February 2016, the number of people counted as 'employed' increased by 2,357 and the number of people counted as 'unemployed' or actively seeking work decreased by 776, resulting in a 1.5 percent increase in the size of the labor force and a drop in the unemployment rate. Whatcom County's labor force was about 108,853 in February 2017.
- Initial claims for unemployment benefits in Whatcom County increased from 929 in January to 969. Altogether, 1,985 Whatcom County residents collected unemployment insurance benefits in February; down from 2,139 in January.

Nonfarm payroll jobs in Whatcom County expanded by 700 from January to February 2017. Year-over-year, the tally of nonfarm jobs is up 1,900 or 2.1 percent.

• In February, goods producing industries collectively gained 200 jobs. Private service providers added 200 jobs and government employers added 300 over the month. Most industries detailed in this report added jobs over the month, with the exception of retail

- trade (a subset of trade transportation and utilities) which shed 300. The largest month-to-month gains were attributable to hiring in government.
- Altogether, Whatcom County employers added 1,900 jobs over the past 12 months. The largest private sector gains were attributed to hiring in trade transportation and utilities (+400) with half of the jobs observed in the retail trade industries. Construction and leisure and hospitality each added 200. Only one industry shed employment over the year; professional and business services industries collectively shed 100 jobs.

# **Skagit County**

### **Local Area Unemployment Statistics**

The unemployment rate in Skagit County was 6.7 percent in February 2017 (preliminary), down from 7.2 percent in January (revised). The unemployment rate in February 2016 was 7.7 percent. Skagit County's unemployment rate has been on a slow but steady decline (with predictable seasonal bumps) since 2010.

- Compared to February 2016, the number of people counted as 'employed' increased by 1,131 and the number of people counted as 'unemployed' or actively seeking work decreased by 527. Skagit County's labor force was estimated as 58,187, having increased by 1.0 percent over the year.
- Initial claims for unemployment benefits in Skagit County decreased from 618 in January to 570. Altogether, 1,335 Skagit County residents received unemployment insurance benefits in February. This is down from 1,628 in January.

In February 2017, Skagit County nonfarm payrolls expanded by 100. Year-over-year, the tally of nonfarm jobs expanded by 1,000 or 2.1 percent.

- In February, construction added 100 new jobs but manufacturing and retail trade each shed 100. January and February tend to be slow months in terms of hiring. Expect hiring to pick up over the spring months.
- Over the year, total nonfarm employment expanded by 1,000 or 2.1 percent, with most industries adding jobs. The largest employment gains were observed in trade transportation warehousing and utilities (+500) including retail trade (+200) and in construction (+400). Year over year losses were observed in manufacturing (-300).

# **Island County**

# **Local Area Unemployment Statistics**

The unemployment rate in Island County was 5.7 percent (preliminary) in February 2017. This is down from 6.2 percent (revised) in January. For comparison, the unemployment rate in February 2016 was 6.6 percent. The unemployment rate in Island County has been slowly but steadily declining since 2010.

• Compared to February 2016, the number of people counted as 'employed' increased by 1,566 and the number of people counted as 'unemployed' or actively seeking work decreased by 231. Island County's civilian labor force was estimated as 33,630, having increased by 4.1 percent over the year.

• Initial claims for unemployment benefits in Island County decreased from 217 in January to 162. Altogether, 415 Island County residents collected unemployment insurance benefits in February. This is down from 510 the previous month.

Nonfarm payroll jobs in Island County increased by 40 in February 2017. Year-over-year, the tally of nonfarm jobs was up 5.9 percent or 910.

- From January to February, the largest job gains were observed in leisure and hospitality (+30) and in construction and education and health services (+20 each). Losses came from retail trade (-20) and information and financial activities (-10).
- Year-over-year, Island County employment expanded by 910, with growth observed in most industry sectors detailed in this report. The largest gains were attributable to hiring in leisure and hospitality (+320), government (+210) and information and financial activities (+160).

# **San Juan County**

# **Local Area Unemployment Statistics**

The unemployment rate in San Juan County fell from 6.3 percent in January (revised) to 5.3 percent (preliminary) in February. For reference, the unemployment rate 12 months earlier was 6.0 percent. The unemployment rate in San Juan County is highly-seasonal as a result of an orientation toward

tourism. When seasonality is ironed out, average annual unemployment rates reveal that the unemployment rate has basically plateaued at about 5 percent since 2014.

- Compared to February 2016, the number of people counted as 'employed' increased by 239 and the number counted as 'unemployed' or actively seeking work decreased by 43. Altogether, the San Juan County labor force increased by 2.7 percent over the year.
- Initial claims for unemployment benefits in San Juan County decreased from 53 in January to 21. Altogether, 95 San Juan County residents received unemployment insurance benefits in February. This is down from 107 in January.

Nonfarm payroll jobs in San Juan County expanded by 100 in February. Year-over-year, total nonfarm employment was up 160 jobs or 3.3 percent.

- San Juan County has a highly-seasonal economy, due to its orientation toward tourism. Most industries shed jobs in the winter and return with the sun. In February, employment gains were observed in most industries. The largest month-to-month gains were attributable to hiring in manufacturing and leisure and hospitality (+30 each).
- Over the year, employers in San Juan County collectively added 160 jobs. The largest gains were observed in trade transportation and utilities (+90) and education and health services (+50). The deepest losses were observed in leisure and hospitality (-30).
