On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington rose by 6,800 from December

2017 to January 2018. BLS estimates the private sector gained 7,100 jobs during the month and the public sector lost 300 jobs.


On a not seasonally adjusted basis, estimates for January 2017 through January 2018 indicate an increase in employment of 91,900 for the state. The private sector added 82,600 jobs while the public sector gained an estimated 9,300 jobs over the year.

Washington's preliminary seasonally adjusted unemployment rate for January 2018 is 4.7 percent. The revised estimated December 2017 unemployment rate was at 4.7 percent. The January 2017 unemployment rate was 4.9 percent.

BLS estimates of monthly job gains and losses are based on a survey of businesses. Preliminary estimates are subject to revision. December's preliminary estimated gain of 6,100 jobs was revised to a gain of 8,500 jobs.

## **Whatcom County**

#### **Local Area Unemployment Statistics**

The unemployment rate in Whatcom County was 5.7 percent in January 2018 (preliminary), up from 5.0 percent reported in December (revised). The unemployment rate 12 months ago was 6.0 percent.

- Compared to January 2017, the number of people counted as 'employed' increased by 915 and the number of people counted as 'unemployed' or actively seeking work decreased by 361, resulting in a 0.5 percent increase in the size of the labor force and a drop in the unemployment rate. Whatcom County's labor force was about 110,971 in January.
- Initial claims for unemployment benefits in Whatcom County decreased from 900 in December to 851. Altogether, 1,905 Whatcom County residents collected unemployment insurance benefits in January; up from 1,622 in December.

Total nonfarm payroll in Whatcom County dropped by 1,400 from December 2017 to January 2018. Year-over-year, the tally of nonfarm jobs was up 2,300 or 2.5 percent.

- In January, goods producing industries collectively added 200 jobs. Private services providers and government each shed 800 jobs over the month. The only sector reporting employment gains over the month was manufacturing (+200). The deepest losses were attributable to government. January tends to be a month characterized by seasonal declines.
- Over the year, most industries covered by this report added jobs. The largest gains were observed in construction (+1,100), and the only industry reporting losses over the year was leisure and hospitality (-600).

## **Skagit County**

### **Local Area Unemployment Statistics**

The unemployment rate in Skagit County was 6.3 percent in January 2018 (preliminary), up from 5.8 reported in December (revised). The unemployment rate in January 2017 was 6.9 percent.

- Compared to January 2017, the number of people counted as 'employed' decreased by 456 and the number of people counted as 'unemployed' decreased by 371. Skagit County's labor force was estimated as 58,286, having decreased by 1.4 percent over the year.
- Initial claims for unemployment benefits in Skagit County increased from 588 in December to 589. Altogether, 1,334 Skagit County residents received unemployment insurance benefits in January. This is up from 1,209 in December.

In January 2018, Skagit County nonfarm payrolls fell by 800 over the month. Year-over-year, the tally of nonfarm jobs expanded by 200 or 0.4 percent.

- Over the month, all major industry sectors shed jobs. This is not unusual for January. The deepest losses were attributable to trade transportation warehousing and utilities (-400), which includes retail trade (-200).
- Over the year, construction, trade transportation warehousing and utilities (excluding retail trade), leisure and hospitality and government all added jobs. At a broad industry level, the only losses were observed in retail trade.

## **Island County**

#### **Local Area Unemployment Statistics**

The unemployment rate in Island County was 6.1 percent (preliminary) in January 2018. This is up from 5.5 percent in December (revised). The unemployment rate 12 months ago was 6.1 percent.

- Compared to January 2017, the number of people counted as 'employed' increased by 594 and the number of people counted as 'unemployed' or actively seeking work expanded by 38. Island County's civilian labor force was estimated as 34,518, increasing by 1.9 percent over the year.
- There were 199 initial claims for unemployment benefits in Island County in January, up from 182 in December. Altogether, 505 Island County residents collected unemployment insurance benefits in January. This is up from 473 in December.

Nonfarm payroll jobs in Island County decreased by 260 from December 2017 to January 2018 Year-over-year, the tally of nonfarm jobs was up 620 or 3.9 percent.

- From December to January, most industries shed jobs. The largest losses were attributable to trade transportation and utilities and construction (-70 each).
- Year-over-year, all major industries detailed in this report added jobs. The largest gains were observed in leisure and hospitality (+130) and education and health services (+100).

### **San Juan County**

### **Local Area Unemployment Statistics**

The unemployment rate in San Juan County increased from 4.4 percent in December (revised) to 5.4 percent (preliminary) in January 2018. The unemployment rate in January 2017 was 6.0 percent.

• Compared to January 2017, the number of people counted as 'employed' increased by 263 and the number counted as 'unemployed' or actively seeking work decreased by 36. Altogether, the San Juan County labor force consisted of an estimated 7,742 people and increased by 3.0 percent over the year.

• Initial claims for unemployment benefits in San Juan County decreased from 45 in December to 36. Altogether, 114 San Juan County residents received unemployment insurance benefits in January. This is up from 92 in December.

Net nonfarm payroll in San Juan County dropped by 210 from December 2017 to January 2018. Year-over-year, total nonfarm employment was up 270 jobs or 5.5 percent.

- San Juan County has a highly-seasonal economy, due to its orientation toward tourism. Most industries shed jobs in the winter and return with the sun. In January, most industries shed jobs. The largest drop came from the largest sector: leisure and hospitality (-70). The only sector reporting gains was education and health services (+30).
- Most industries added jobs over the year; the largest gains were observed in leisure and hospitality (+170) and information and financial activities (+50). Government was the only industry detailed in this report that shed jobs over the year (-50).
