## NORTHWEST WORKFORCE COUNCIL ANNOUNCES NEW BOARD MEMBERS

### Nancy Steiger, Chief Executive Officer/Chief Mission Officer, PeaceHealth Whatcom Region

Nancy Steiger has led PeaceHealth's operations in northwestern Washington since 2007. Previously she spent five years as CEO of San Mateo Medical Center following service as COO at Santa Rosa Memorial Hospital/St. Joseph Health System, both in northern California. #### Dr. Greg Baker, Superintendent, Bellingham Schools District

Dr. Baker comes to Bellingham Public Schools from Portland, Oregon where he served as a deputy superintendent. He has also served as an intern and special assistant to the superintendent of Boston Public Schools and as an administrator for Spokane Public Schools. He began his career in Alaska as a teacher and assistant coach. Dr. Baker received his doctorate from Harvard University; a master's degree in administration, planning and social policy from Harvard University; and a master's degree in secondary education from Western Washington University. He earned his bachelor's degree with distinction from Gonzaga University.

## Dr. Hart Hodges, Vice President, Waycross Management Investment

Dr. Hodges is responsible for investment research and statistical analysis at Waycross. He is also an Associate Professor of Economics at Western Washington University, where he is Director of the Center for Economic and Business Research.
