

On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington rose by 8,200 from March 2015 to April 2015.1 BLS estimates the private sector gained 8,200 jobs during the month and public sector employment was unchanged.

On a not seasonally adjusted basis, estimates for April 2014 through April 2015 indicate an increase in employment of 110,700 for the state.

The private sector added 98,300

jobs while the public sector gained an estimated 12,400 jobs over the year.

Washington's preliminary seasonally adjusted unemployment rate for April 2015 is 5.5 percent. The revised estimated March 2015 unemployment rate was at 5.9 percent. The April 2014 unemployment rate was 6.2 percent.

BLS estimates of monthly job gains and losses are based on a survey of businesses. Preliminary estimates are subject to revision. March's preliminary estimated gain of 10,500 jobs was revised to a gain of 12,000 jobs.

Whatcom County

Local Area Unemployment Statistics

The unemployment rate in Whatcom County dropped from 5.9 percent in March (revised) to 5.4 percent in April (preliminary). The unemployment rate in April 2014 was 6.3 percent.

- Compared to April 2014, the number of people counted as 'employed' increased by 3,290 and the number of people counted as 'unemployed' or actively seeking work decreased by 850. Whatcom County's labor force expanded by 2,440 over the year.
- Initial claims for unemployment benefits in Whatcom County decreased from 966 in March to 868. The largest number of new claims was filed by persons in construction-related occupations. Altogether, 1,690 Whatcom County residents collected unemployment insurance benefits in April; down from 1,997 in March.

Nonfarm payroll jobs in Whatcom County expanded by 400 from March to April 2015. Year-over-year, the tally of nonfarm jobs is up 4.3 percent or 3,700.

- In April 2015, all major sectors in this report either expanded employment or remained at March levels. Construction and retail trade each added 300 jobs over the month.
- Private sector employers collectively reported a gain of 2,600 jobs over the year. The largest private sector gains were attributed to hiring in trade, transportation, warehousing and utilities (+1,000) and construction (+900). The only major industry group reporting losses

over the year was leisure and hospitality (-400). Public sector employment expanded by 1,100 over the year.

Skagit County

Local Area Unemployment Statistics

The unemployment rate in Skagit County declined from 7.0 percent in March (revised) to 6.2 percent (preliminary) in April 2015. The unemployment rate last April was 7.0 percent.

- Compared to April 2014, the number of people counted as 'employed' increased by 910 and the number of people counted as 'unemployed' or actively seeking work decreased by 390. Skagit County's labor force increased by an estimated 520 workers over the year.
- Initial claims for unemployment benefits in Skagit County decreased from 689 in March to 618. The largest number of new claims was filed by persons in construction-related occupations. Altogether, 1,181 Skagit County residents received unemployment insurance benefits in April. This is down from 1,418 in March.

In April, Skagit County nonfarm payrolls expanded by 1,300. Year-over-year, the tally of nonfarm jobs also expanded by 800 or 1.7 percent.

• Month-to-month, all major sectors detailed in this report expanded employment. The sector that created the largest number of jobs over the month was trade transportation (which includes retail), which added 400 jobs.

• Over the year, total nonfarm employment increased by 800 or 1.7 percent, with each major industry detailed in the table reporting employment gains. The largest gains were attributed to trade transportation warehousing and utilities (+600) Four hundred of these jobs were in retail. Leisure and hospitality also added 400 jobs over the past 12 months.

Island County

Local Area Unemployment Statistics

The unemployment rate in Island County decreased from 6.2 percent (revised) in March to 5.8 percent in April (preliminary). The unemployment rate in April 2014 was 6.4 percent.

- Compared to April 2014, the number of people counted as 'employed' increased by 360 and the number of people counted as 'unemployed' or actively seeking work decreased by 160. Island County's civilian labor force increased by 200 residents over the year.
- Initial claims for unemployment benefits in Island County increased from 178 in March to 201. The largest number of new claims was filed by persons in construction-related occupations. Altogether, 404 Island County residents collected unemployment insurance benefits in April. This is down from 463 the previous month.

Nonfarm payroll jobs in Island County increased by 240 in April. Year-over-year, the tally of nonfarm jobs was up 2.5 percent or 390.

- From March to April, most major industries detailed in this report either added jobs or maintained levels of employment. The only exception is information and financial activities which shed 10 jobs.
- Year-over-year, Island County added 390 jobs. The largest gains were observed in leisure and hospitality (250), government (90) and construction (70). The deepest losses were from professional and business services (-70) and retail trade (-40).

San Juan County

Local Area Unemployment Statistics

The unemployment rate in San Juan County decreased from 5.3 percent (revised) in March to 4.5 percent (preliminary) in April. The unemployment rate observed in April 2014 was 4.9 percent.

- Compared to April 2014, the number of people counted as 'employed' increased by 230 and the number counted as 'unemployed' or actively seeking work decreased by 30. All together, the San Juan County labor force increased by 200 over the year.
- Initial claims for unemployment benefits in San Juan County decreased from 45 in March to 28. The largest number of new claims was filed by persons in food preparation and serving related occupations. Altogether, 92 San Juan County residents received unemployment insurance benefits in April. This is down from 92 in March.

Nonfarm payroll jobs in San Juan County in April expanded by 70. Year-over-year, total nonfarm employment was up 110 jobs or 2.2 percent.

- San Juan County has a highly-seasonal economy, due to its orientation toward tourism. As summer approaches, we are now in the time of year where we can expect to see month-to-month growth in employment. The largest one-month shift in April was a gain of 80 jobs in retail trade.
- Over the year, San Juan County added 110 jobs. The largest number of jobs was added in trade transportation and utilities (which includes retail trade). Despite a warm spring, employment in leisure and hospitality was down over the year (-50) along with construction and professional and business services (down 20 and 10 jobs respectively).
