# Northwest Washington Labor Market Review

On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington fell by 7,200 from December 2016 to January 2017. BLS estimates the private sector lost 3,600 jobs during the month and the public sector lost 3,600 jobs.

On a not seasonally adjusted basis, estimates for January 2016 through January 2017 indicate an increase in employment of 84,600 for the state. The private sector added 73,800 jobs while the public

sector gained an estimated 10,800 jobs over the year.

Washington's preliminary seasonally adjusted unemployment rate for January 2017 is 5.1 percent. The revised estimated December 2016 unemployment rate was at 5.1 percent. The January 2016 unemployment rate was 5.6 percent.

BLS estimates of monthly job gains and losses are based on a survey of businesses. Preliminary estimates are subject to revision. December's preliminary estimated gain of 3,600 jobs was revised to a gain of 8,000 jobs.

# **Whatcom County**

### **Local Area Unemployment Statistics**

The unemployment rate in Whatcom County was 6.4 percent in January 2017 (preliminary), up from 5.8 percent in December 2016 (revised). For comparison, the unemployment rate in January 2016 was 6.6 percent. In the past year the downward-trending unemployment rate has slowed in its descent.

- Compared to January 2016, the number of people counted as 'employed' increased by 1,046 and the number of people counted as 'unemployed' or actively seeking work decreased by 204, resulting in a 0.8 percent increase in the size of the labor force and a drop in the unemployment rate. Whatcom County's labor force was about 108,622 in January 2017.
- The increase over the month was seasonal, and is observed every year in the aftermath of holiday-related hiring and subsequent layoffs. Expect the unemployment rate to begin to drop once again in March.
- Initial claims for unemployment benefits in Whatcom County decreased from 1,327 in December to 929. Altogether, 2,462 Whatcom County residents collected unemployment insurance benefits in January; up from 1,848 in December.

Nonfarm payroll jobs in Whatcom County contracted by 2,000 from December 2016 to January 2017. Year-over-year, the tally of nonfarm jobs is up 1.2 percent or 1,100.

- In January 2017, goods producing industries collectively maintained the employment levels observed in December. Service providers shed 2,000 jobs. Government employment declined by 300 over the month. The deepest job losses in January were observed in the collection of trade, transportation, warehousing and utilities (-500), with losses specifically observed in retail trade (-400), and reflects the aftermath of holiday hiring.
- Altogether, Whatcom County employers added 1,100 jobs over the past 12 months. The largest private sector gains were attributed to hiring in retail trade (+400) and leisure and hospitality and government (+300 each). Only one industry shed employment over the year; professional and business services industries collectively shed 100 jobs.

# **Skagit County**

### **Local Area Unemployment Statistics**

The unemployment rate in Skagit County was 7.3 percent in January 2017 (preliminary), up from 6.7 percent in December 2016(revised). The unemployment rate in January 2016 was 7.7 percent. Skagit County's unemployment rate has been on a slow but steady decline (with predictable seasonal bumps) since 2010. In the past year, the rate has more-or-less stabilized.

- Compared to January 2016, the number of people counted as 'employed' increased by 1,040 and the number of people counted as 'unemployed' or actively seeking work decreased by 163. Skagit County's labor force was estimated as 58,453, having increased by 1.5 percent over the year.
- Initial claims for unemployment benefits in Skagit County decreased from 1,044 in December to 618. Altogether, 1,866 Skagit County residents received unemployment insurance benefits in January. This is up from 1,307 in December.

In January 2017, Skagit County nonfarm payrolls contracted by 700. Year-over-year, the tally of nonfarm jobs expanded by 800 or 1.7 percent.

- In January, all industries detailed in this report either shed net jobs or remained unchanged, with the exception of state government which added 100 jobs. The deepest one month losses were observed in the collection of industries that include trade, transportation, warehousing and utilities (-400). January job losses are expected and are largely a product of seasonal employment cycles.
- Over the year, total nonfarm employment expanded by 800 or 1.7 percent, with most industries adding jobs. The largest employment gains were observed in trade transportation and warehousing (+500) including retail trade (+300) and in leisure and hospitality and construction (+300 each). Year over year losses were observed in manufacturing (-200) and state government (-100).

# **Island County**

# **Local Area Unemployment Statistics**

The unemployment rate in Island County was 6.3 percent (preliminary) in January 2017. This is up from 5.7 percent (revised) in December 2016. For comparison, the unemployment rate in January 2016 was 6.7 percent. The unemployment rate in Island County has been slowly but steadily declining since 2010.

- Compared to January 2016, the number of people counted as 'employed' increased by 1,567 and the number of people counted as 'unemployed' or actively seeking work decreased by 46. Island County's civilian labor force was estimated as 33,951, having increased by 4.7 percent over the year.
- Initial claims for unemployment benefits in Island County decreased from 303 in December to 217. Altogether, 600 Island County residents collected unemployment insurance benefits in January. This is up from 397 the previous month.

Nonfarm payroll jobs in Island County decreased by 270 in January 2017. Year-over-year, the tally of nonfarm jobs was up 6.5 percent or 990.

- From December 2016 to January 2017, most industries shed jobs. The deepest losses were observed in trade transportation and utilities (-90), particularly in retail trade (-80). Construction also shed 80 jobs over the month. Employment gains were observed in education and health services (+10).
- Year-over-year, Island County employment expanded by 990, with growth observed in all industry sectors detailed in this report. The largest gains were attributable to hiring in leisure and hospitality (+300), government (+220) and information and financial activities (+190).

# **San Juan County**

### **Local Area Unemployment Statistics**

The unemployment rate in San Juan County rose from 5.1 percent in December 2016 (revised) to 6.3 percent (preliminary) in January 2017. For reference, the unemployment rate 12 months earlier was 6.7 percent. The unemployment rate in San Juan County is highly-seasonal as a result of an orientation toward tourism. When seasonality is ironed out, average annual unemployment rates reveal that the unemployment rate has basically plateaued at about 5 percent since 2014.

- Compared to January 2016, the number of people counted as 'employed' increased by 233 and the number counted as 'unemployed' or actively seeking work decreased by 14. All together, the San Juan County labor force increased by 3.0 percent over the year.
- Initial claims for unemployment benefits in San Juan County decreased from 56 in December to 53. Altogether, 124 San Juan County residents received unemployment insurance benefits in January. This is up from 91 in December.

Nonfarm payroll jobs in San Juan County contracted by 260 in January. Year-over-year, total nonfarm employment was up 170 jobs or 3.5 percent.

- San Juan County has a highly-seasonal economy, due to its orientation toward tourism. Most industries shed jobs in the winter and return with the sun. In January, employment losses were observed in most industries. Leisure and hospitality logged the deepest losses (-130).
- Over the year, employers in San Juan County collectively added 170 jobs. The largest gains were observed in trade transportation and utilities (+60) and education and health services (+40). The deepest losses were observed in construction (-30).
