Notes:

- For PY 21 WIOA Performance, only Title IB and Title III are subject to DOL sanction for the following two performance indicators: (1) Employment and (2) Median Earning 2nd Qtr. after Exit.
- In the Northwest Region, there are currently has five (5) contract providers of Adult Basic Education (BEa) services. Their current MIS data system does not allow access to quarterly performance outcomes, only the Annual outcomes. Measurable Skills Gains (MSG) are captured quarterly but data appears unreliable.
- Temp. Assistance to Needy Families (TANF), called WorkFirst in WA State, was included by the Governor as part of the WIOA Workforce System. Currently, this program has some performance measures that are similar to the current WIOA measures Median Placement Wages, Exits to Employment, and Job Retention. There are not performance targets established for these TANT measure but Local Planning Areas (LAP) are compared to: 1) state rate, 2) prior 3 months, & 3) same period last year.
- Quarter 3 data is not yet available for WIOA Title IV (Voc Rehab), SCSEP, or Title I Job Corps.
- OIC of Washington (WSFW Programs) has reported for both their Adult and Youth populations served.
